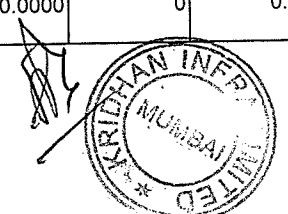

Out of the said warrants the promoters have exercised their right of conversion of 62,25,000 warrants (before augmentation 12,45,000 warrants) and accordingly the Board of Directors have issued 62,25,000 equity shares of Rs.2/- each to the promoters of the Company & balance 72,75,0000 are outstanding & pending for conversion.
